PROCLAMATION

Declaring the 1st Day of February 2017 as a Day to Honor the Dayton Valley Branch Library

WHEREAS, On February 1, 1997 the Dayton Valley Branch Library first opened its doors to serve the community of Dayton in Lyon County, Nevada; and

WHEREAS, the library building was the result of a small group of Dayton citizens wanting their community to build a library who incorporated the Friends of the Dayton Valley Library in September of 1988 in an effort to reach their goal; and

WHEREAS, against the odds of a community group achieving such a hefty goal, the Friends started going to County Commissioner meetings. Despite obstacles such as being told the county didn't have the money and a library wasn't needed because 'People in Dayton Don't Read', the Friends became more determined and continued going to Commissioner meetings, organizing bake sales, and other fund raisers, going door to door and soliciting businesses until they convinced the County to build the library by raising the needed matching funds; and

WHEREAS, since opening, the library has been a welcoming oasis which proudly serves the community with much needed library services from books to computerized content, and programs for all ages from Story Time to Book Clubs and Summer Reading to Authors nights; and

WHEREAS, 20 years later, in 2017, despite an increasingly digital world, The Dayton Valley Branch Library continues to be a relevant and vital asset to its community;

NOW THEREFORE, we the Lyon County Commissioners do hereby proclaim February 1, 2017 as a day in honor of the 20th Anniversary of the Dayton Valley Branch Library.
