3 **Definition of stalking, aggravated stalking and harassment:**

4 **Stalking:** A person commits the crime of stalking when, without lawful authority, that
5 person willfully or maliciously engages in a course of conduct directed towards a victim that
6 would cause a reasonable person under similar circumstances to feel terrorized, frightened,
7 intimidated, harassed or fearful for his or her immediate safety or the immediate safety of a
8 family or household member, and that actually causes the victim to feel terrorized, frightened,
9 intimidated, harassed or fearful for his or her immediate safety or the immediate safety of a
10 family or household member. NRS 200.575(1)

11 **Aggravated Stalking:** A person who commits the crime of stalking and in conjunction
12 therewith threatens the person with the intent to cause the person to be placed in reasonable
13 fear of death or substantial bodily. NRS 200.575(2)

14 **Harassment:** A person commits harassment when: (a) Without lawful authority, the person
15 knowingly threatens: (1) To cause bodily injury in the future to the person threatened or to any
16 other person; (2) To cause physical damage to the property of another person; (3) To subject
17 the person threatened or any other person to physical confinement or restraint; or (4) To do
18 any act which is intended to substantially harm the person threatened or any other person with
19 respect to his or her physical or mental health or safety; and (b) The person by words or
20 conduct places the person receiving the threat in reasonable fear that the threat will be carried
21 out. NRS 200.571

23 **Definition of sexual assault:** A person commits sexual assault if they subject another person
24 to sexual penetration, or forces another person to make a sexual penetration on himself or
25 herself or another, or on a beast, against the will of the victim or under conditions in which the
26 perpetrator knows or should know that the victim is mentally or physically incapable of
27 resisting or understanding the nature of his or her conduct. NRS 200.366

28 **Protection of Children:** The parent or guardian of a child may petition any court of
competent jurisdiction on behalf of the child for a temporary or extended order against a
person who is 18 years of age or older and who the parent or guardian reasonably believes has
committed or is committing a crime involving: (a) Physical or mental injury to the child of a
nonaccidental nature; or (b) Sexual abuse or sexual exploitation of the child. NRS 33.400
