

# Stagecoach Advisory Board Minutes

1. **Call to Order:** 7:00 call to order.

2. **Roll Call: Determination of a Quorum:** All Board Members Present: Cassandra Aviero, Amanda (Mandy) Brinnand, Charles (Charlie) Shirley, Annette Carpenter, Angela DeFord

3. **Pledge of Allegiance:** Rebecca Martinez was asked to lead in the pledge.

4. **Public Participation:**

Mandy said at the November Stagecoach Advisory Board meeting there was an agenda item for Bryan Gauck Iroquios Trail, for tentative map approval to subdivide about 24 acres into 4 about 5-acre parcels. This was also on the planning commission agenda in November where Mr. Gauck requested an up to 90-day continuance to rectify the compliance issues, this was approved by the Planning Commission. This item is now on the January 10 Planning Commission agenda and the report and comments from the November Stagecoach Advisory Board meeting are included on their agenda. Attended a joint Churchill/Lyon County water workshop, the presentations were a little confusing, but a lot were on if there is enough water; was an interesting meeting. Bill Roth was announced as the new Lyon County Senior Planner. Ken Gray stepped down as a County Commissioner, applications for his vacant seat will be accepted through January 10<sup>th</sup>, BOCC will forward 3 names to Governor Lombardo, who will make the selection. Stagecoach agendas are posted on the Lyon County website, this is the official posting and only place required to post. But I also post at Stagecoach Junction, AJ's and Stagecoach Market bulletin boards, SGID also posts on their billboard. Just received a key and will now also be posting at the community center in the glass case outside the door.

Sid they want to train and make 2 separate departments, so they can run each and will be able to have more staff proportionally.
