

Dayton Regional Citizens Advisory Board Meeting Minutes

Wednesday, April 5th, 2023, at 7:00 p.m.

1. Call to Order:

- Vice-Chair (Acting Chair) Christopher Gonzales called the meeting to order at 7:00 pm

2. Roll Call: Determination of a Quorum

- Christopher Gonzales, Regina Lee, and Norman Lee present, quorum was achieved. Elaine St John was absent.

3. Pledge of Allegiance

4. Public Participation:

- Karen Saunders: The trash caused by the homeless population down at the river has now gone down stream due to recent storms. More people have been showing up. The issue has not been taken care of.

5. For Possible Action: Review and adoption of agenda for April 5th, 2023

- Mrs. Lee motioned to approve agenda, Mr. Lee 2nd. Motion passed 3-0

Mr. Gonzales read loud a message from the County Managers office that Board Member and Chair Ralph Ewing had been appointed to the Lyon County Planning Commission and was required to resign from the Dayton Regional Citizens Advisory Board (DRCAB). The DRCAB would be allowed to re-hold elections for Officers. Mr. Gonzales stated that items 6, 7 and 8 would be taken at the same time.

Mrs. Lee stated that she was interested in being Chair. Mr. Lee stated he was interested in being Vice-Chair. Mr. Gonzales stated that he would be interested in being Secretary.

- Mrs. Lee motioned for Christopher Gonzales to be Secretary for the remainder of 2023, Mr. Lee seconded. Motion passed 3-0

9. For Possible Action: Approve minutes of meeting March 1st, 2023

- Mr. Gonzales requested to change typo in Agenda of the wrong year on Item 6.

- Mr. Lee motioned to Approve minutes with changes, Mr. Gonzales seconded, motion passed 3-0.

10. Community Reports

- Lyon County Commissioner/Manager Office
 - Commissioner Henderson gave a summary of the Legislation Bills that the Board of County Commissioners (BOCC) is tracking.
 - He stated that Lyon County had a wet winter and the Commissioner wanted to thank all the County staff for their hard work.
 - He stated that there is a special meeting on the County budget coming up.
 - Mrs. Lee asked about the new opening on the planning commission and Mr. Henderson verified that someone had recently vacated their position.
- Lyon County Sheriff
 - Cmdr. Ortiz gave a summary on the Saturation Patrol that the Sheriff performed in the Dayton area.
 - Cmdr. Ortiz fielded a question about a recent collision on US 50 and about driver maneuvers using the Two-way-left-turn-lane (TWLTL).
- Mrs. Lee read a message from the Managers Office about County Board Member training.

- Mrs. Lee stated that the Senior Center was having a craft fair on April 22.
- Mrs. Lee read aloud a message from Ralph Ewing, former DRCAB member addressing his departure from the board.
- Mrs. Lee read an email about April being Child Abuse Prevention month and an event being held at Our Park.
- Mrs. Lee read an e-mail addressing interest in building a community pool in Dayton.

12. Chair & Board Member Comments & Agenda Requests

- Mr. Lee stated that he would like Lyon County IT to fix the boards computer issues.
- Mr. Gonzales stated that the DRCAB now has an opening.
- Mrs. Lee talked about the Stop Signs and striping on Dayton Valley Road and thanks Mrs. St John for addressing issues.

- Camille Vecchiarelli: Stated that the recent bad weather has caused a large amount of damage to existing roads in the Dayton Area. She would like to see if the community can receive an update on what the County's plans to address the problems is.
- Russell: Stated that the crosswalks along Dayton Valley Road do not all have the Rectangular Rapid Flashing Beacons, and he states that the ones that don't are dangerous for the kids walking to school. He would love to see lighting on these crosswalks.
