Re: **Courthouse Redesign Construction Schedule**

Dt: March 27, 2023

Commencing the week of Memorial Day (May 30, 2023), it is anticipated that the notice to proceed with the Courthouse Redesign Project will be issued. The project is expected to last approximately one year from that time. As a result, the Court will be implementing revised schedules and will be primarily located in the historic Lyon County Courthouse at 31. S. Main Street, Yerington, NV. During Court Operations, the Courthouse will be a secured building. Therefore, any Firearms or other dangerous weapons will be prohibited.

COURT CLERK OPERATIONS:

The Court Clerk's Office will temporarily move to the second floor of the historic Courthouse across from the Courtroom (Main Street side). All mailed filings will be forwarded to the new location so it will not be necessary to modify the Court's address on any mailings. However, in person filing will be had at the physical location in the historic building. All current phone numbers and emails will remain the same.

DISTRICT COURT SCHEDULE:

LAW AND MOTION CALENDAR:

Dept. I, Judge Schlegelmilch: Will be held in his current Courtroom in the New Courthouse on Monday Mornings commencing at 9:00 a.m. in accordance with his existing schedule. The Courtroom (now designated Courtroom 1, was B) will be the only facility available in the new Courthouse once construction commences. In the event construction interferes with the use of the

Courtroom, the location and/or time of Judge Schlegelmilch's L&M calendar may change.

Dept. II, Judge Aberasturi: Will be held in the Old Courthouse Courtroom commencing at 9:00 a.m. in accordance with his existing schedule.

JURY TRIALS:

All jury trials for the ensuing year will be scheduled in the old Courthouse. The Court has invested significant tech into the old courtroom to accommodate most everyone's needs. Generally, Judge Schlegelmilch will schedule jury trials for the first 2 weeks of the month and Judge Aberasturi for the last two weeks of the month.

BENCH TRIALS, OTHER HEARINGS AND SETTLEMENT CONFERENCES:

It is our intention to set most matters in the old Courthouse. However, in the event it becomes necessary, the Court will possibly schedule hearings and other matters in alternate areas/means, including Zoom, the Lyon County Commission Chambers and Courtroom 1 in the event of conflicting schedules between the judges. Please verify your location with the Court's Judicial Assistants prior to the hearing.

HANDICAP ACCESS:

Handicap access will be available through the rear of the old Courthouse. In the event any person needs special accommodations, please notify the Court immediately. The hearing will then be set in either the County Commission Chambers or Courtroom 1. There will be handicap access into the building through the rear entrance.

COURT CHAMBERS:

The Court's Chambers for both departments and staff will be located on the second floor of the old Courthouse. All phone numbers and emails will remain the same throughout the construction period.

DRUG COURT:

Drug Court will maintain its existing schedule of every Wednesday commencing at 1:30 with staffing taking place prior to Court. The Drug Court will be temporarily located in the Lyon County Commission Chambers.
